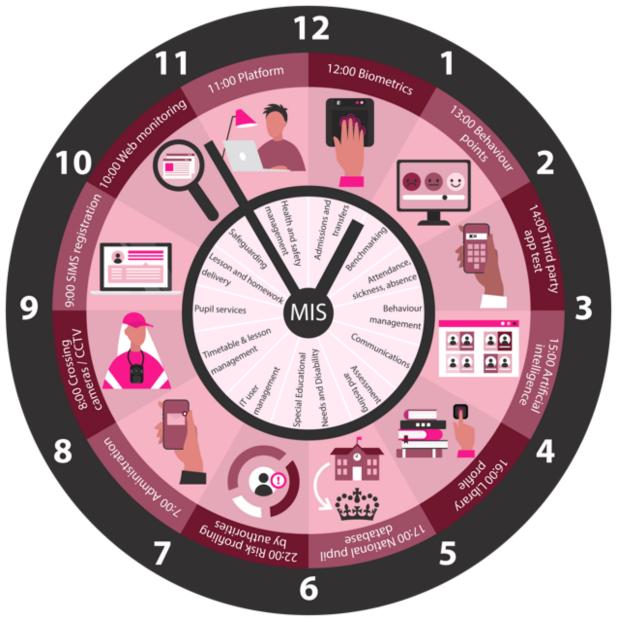
# A: A day-in-the-life of a datafied child in state education

From before breakfast to bedtime and beyond, a pupil's personal data are collected and may be transferred to hundreds of third parties in one day and thousands across their lifetime education. For school administration and central information management systems, and for communications, and use by local and national pupil databases. By apps, platforms, cashless payment systems, including biometrics, special educational needs and disability, and health data. On behavioural platforms, in exams and tests (state mandated and with a wide range of commercial test suppliers), in safeguarding software, seating plans, borrowing library books, and at after-school clubs. On CCTV, classroom cameras, lesson capture tools, and classroom and patrol bodycams. And even at home, for their homework, logged into school accounts, and around the clock. There is no way a child can understand or track their digital footprint by the time they are 18 or have any ability to reclaim control over it.



## B. What do we mean by personal data in education?

i.Only a small part of the data about a child is provided by the child or family. A vast amount of data in schools is ascribed by staff and may not only be fact based, but can also be, observed, derived and inferred. Commercial companies interact daily with a child through

- School information management systems (SIMS systems)
   Around fifteen key UK providers, many cloud based, provide schools with core pupil administrative data management systems, based on a lifetime unique ID pupil number. Systems hold hundreds of items of data about each child and transfer individual level data between schools via the electronic CTF (Common Transfer File).
- Third-party apps, platforms, biometrics, CCTV and classroom camera systems SIMS systems also distribute pupils' and parents' personal data held by schools, to a huge range of third parties. The market of commercial providers to schools that process children's personal data is largely unseen by parents. A survey of parents in England we commissioned in 2018, found that only half of parents agree they had enough control of their child's digital footprint, and one in four parents said they do not know if their child has been signed up to any systems using personal data at all.

National and regional data extractions
 SIMS systems distribute pupils' and parents' personal data held by schools, to other public bodies, some nightly, some termly or annually. These data may be processed by machine based algorithms to analyse a variety of data, and linked with other public sector data about the child and their family, such as third-party sources via social media, location data and records of activities in order to score and risk profile people for example in terms of their behaviour, state of health, or safeguarding.

ii. Parents' details are stored alongside children's personal confidential data in core school information management systems, and some, such as email address, have become routinely distributed to third parties without sufficient due diligence or understanding of the companies' commercial purposes behind the tools. Parents cannot see data created and inferred by the companies through the use of the product, such as profiling from IP address. 'Free' commercial third party actors are built on often business models that charge parents for access to additional educational content and activities about their children using data gathered in the classroom, to pitch products to them at home directly via their email.<sup>1</sup> There is a postcode lottery of how these affect children's privacy. For example, an app on the red 'declined list' used by the Dundee Local Authority, may be widely used in schools in England. And in England some schools may have a due diligence policy, in others teachers may decide individually which apps to use, or whether to become a "Google Certified Educator" or "Apple Distinguished Educator" and introduce their schools to new providers.

iii. Commercial data processing of children's (and their families') personal confidential data is carried out 24/7 and 365 days a year, not only during school hours, and can continue unseen long after they leave compulsory education, and for life.

iv.Many policies in practice stretch beyond the school premises and activities. For example in school safeguarding surveillance software which may be invisibly present on school issued laptops, personal devices or switched-on in personal spaces, out-of-school hours, and monitor private and family life at home.

## C. National pupil data distribution for commercial re-use (England)

i. Indirect re-use of state data collections of individual pupil level data, which are given away to commercial companies, begins as soon as a child's personal data is sent to the four Departments for Education in the compulsory termly census which parents' never see.

ii. England has the most egregious harms to privacy in terms of national government data releases to commercial companies. Each school census collection feeds as one of twenty five datasets merged into the National Pupil Database, now holding over 21 million named individual records. Children's personal data have been copied and passed on by the DfE since 2012 to thousands of commercial 'researchers', including for linking information at pupil level and developing predictive tools. Commercial re-use by analytics firms,<sup>2</sup> think tanks and charities, account for more than 40% of use by third-parties.<sup>3</sup>

iii.These include companies such as Mime Consulting who boast that they can, "track a child in England, anywhere they go [in the school system]."<sup>4</sup>

iv.The data when released to third-parties, are not anonymous, but are detailed, sensitive<sup>5</sup> and identifying.<sup>6</sup> Each release can include several million individual records.Schools Minister Nick Gibb confirmed in January 2018 that,

"According to centrally held records at the time of writing, from August 2012 to 20 December 2017, 919 data shares containing sensitive, personal or confidential data at pupil level have been approved for release from the National Pupil Database."

v. There is no transparency of the volume of how many children's data have been given away in each approved release, because,

"the Department does not maintain records of the number of children included in historic data extracts." (PQ109065)

vi. The Department is aware that they share and distribute too much data with third party users, calling it an 'excessive' amount of data in the underlying datasets'.

"Users are required to download the entire dataset, then remove and manipulate extraneous data reducing it to a specific subset. Many expressed a desire to be able to customise the data they downloaded."<sup>7</sup>

vii. A summary Data Protection Impact Assessment published by the Department for Education in May 2019 for the first time, also revealed risks about the scope of use of personal information and people are not aware of its use:

"is not restricted due to insufficient governance controls,"... "may not be aware that their personal data may be shared with other organisations."

viii. When it comes to a child's personal data being passed from a school to third parties or to the Department for Education (DfE) and onwardly shared, parents want to be asked for consent. Survation<sup>8</sup> asked 1,004 parents of state-educated children age 5-18 on behalf of defenddigitalme, between 17th – 20th February 2018 about their understanding of which technologies are used, and how data are used. Most strongly parents consider children's special educational needs data merits extra consideration, before a school passes that sensitive information on to the Department for Education (DfE) for secondary re-uses.

- 81% of parents agreed that parental consent should be required before a child's special educational needs data is shared.
- 60% parents agreed parental consent should be required before schools pass data to the DfE National Pupil Database.
- 65% agreed the Department for Education should have parental consent in order to pass children's personal data to commercial data analytics companies.
- Over three quarters (79%) if offered the opportunity to view their child's named record in the National Pupil Database would choose to see it. The Department cannot meet requests adequately.
- While parents give the Department for Education a high level of trust to use data well (68%), almost the same number of parents (69%) said they had not been informed the DfE may give out data from the National Pupil Database to third parties.

### D. Higher Education: commercial companies and data re-use

i. In Higher Education, marketisation is driving a perceived need for demonstrable metrics created from reusing student data collected as part of the admissions process, or everyday studies. This is fulfilled in UK universities by local and cloud based tools; such as but not only: Altryx, Blackboard, Brightspace, Business Intelligence/Open Text, Civitas, Google Analytics, Google Data Studio, Heidi Plus, IBM, JISC, MATLAB, Minitab, Ms Excel, MSSQL Stack, Cognos, Oracle SIA / BIE, Panopto, Piwik, Power BI, Pyramid, QlikView, SAP Business Object / Business Warehouse, SEATS, SQL Data warehouse, SSRS, Starfish, Stata, Stream / SolutionPath, Tableau, Tribal, and USW.

ii At the time of writing, personal data processing at scale appears to be ramping up at pace. In part this is due to government and press generated pressure to monitor students under well-being frameworks, but that could arguably largely be seen to be about reputational risk.
